



Monte Chamberlin, Founder of Cost Stewardship comes highly recommended based on his service and continued assistance to Union Chapel Ministries in Muncie, IN; our opinion is based both on his results and his character. We are a church of about 1200 weekend attendees and have substantial utility bills. Monte was able to successfully manage the refund of almost four years of sales taxes paid on our utilities and the result was many, many thousands returned for use in ministry. We received a letter from Indiana Revenue exempting all future utility bills which means we will never have to apply for exemptions from the State again.

Monte also brought a team with him to look at other costs. We are seeing roughly 10% to 30% purchase savings on many office supplies in the few months since their visit. We look forward to reviewing their proposals on copiers, telecommunication, and other items. Based on our experience with Cost Stewardship, we anticipate more savings which can be used to fund more ministries and outreach.

Beyond the hard facts of saving money, Monte will do it all with class and a demeanor that makes him very pleasant to work with. We have talked about a number of potential saving opportunities beyond the scope of Cost Stewardship programs and other endeavors since our initial meeting, and Monte seems well versed in many categories. His advice has proved useful when we were seeking wise counsel.

I highly recommend partnering with Cost Stewardship, and I use the word "partnering" since that is exactly what you will receive with this group.
